Composition

- Support made of cotton lattice
- Protective sheets
- Impregnation: neuter base made of Vaseline and Paraffin

Clinical benefits

- On the wound, the dressing assure a contact interface that creates the favorable local microclimate for the cicatrization process (cicatrization in moist environment)
- It is not adherent (to tissues) to the wound: removal is easy and atraumatic
- Easy to apply in the case of wounds found in difficult areas (e.g. anatomical folds. mucocutaneous junctions, etc.)

Performance characteristics

- Using the products, helps to reduce:
 - the healing and treatment time
 - 0 the treatment costs

Indications

- Local treatment of acute wounds: first, second a and b degree burns, excoriations, traumatic
- Local treatment of bedsores and chronic vascular ulcers

Contra-Indications

There are no contraindications

Instructions for use

- The wound must be cleaned with hypertonic solutions (physiological serum), before each use of the paraffin dressing
- In case of previous usage of an antiseptically, wash the wound with physiological serum before applying the paraffin dressing
- The paraffin dressing is applied in a single layer directly on the wound, after removal of protective sheets.
- This dressing can be cut according with the size and/or form of the wound, using a sterile
- Cover the wound with a secondary compress (sterile gauze or non-woven compress) and fix it with an extensible or fix bandage, adhesive or not
- The dressing is replaced every day or every 1-2 days, depending of the wound healing process

for use

Precautions • If there are signs of local infection, treatment can be continued with the physician's approval

- Additional The presence of a deep wound does not involve the use of multiple dressings at the same time
- precautions Single-use product; DO NOT re-sterilize
 - · Sterile only if the packaging is not damaged
 - Storage:
 - Protected from humidity and sunshine
 - o Temperature: max. 35ºC.

Undesirable side- • None known. effects

- Warnings Products are single use medical devices, do not re-use! Otherwise it may appear: irritation /contamination/ infection of wound and/or skin
 - The product is exclusively for external use: ingestion of the impregnation base may cause stomach problems
 - For people with mental disabilities, the products should only be used under supervision of a mentally healthy.
 - Do not use the product if the packaging is damaged
 - The products should not be further used after the expiration date.
 - The products should be kept away from children and pets. Penetration in the wound of hair or stains from pets can cause wound contamination


